Request for Applications

The A. Charles Holland Foundation invites applications for a Scholarship in the field of Audiology/Otology. The Scholarship is intended to support a training stage of 2-3 months at a specialized Department (different from current affiliation) for trainees in Audiology/Otology. Applications should include the object and duration of the training, including the Department where it could be undertaken (together with its written agreement), a CV describing specific fields of interest and previous experience, a list of publications if any and a letter of recommendation from the current Head of Department. Applications (in English) should be submitted by December 31st, 2008 and will be evaluated by three members of the Foundation Scientific Committee. The winners will be notified by March 31st, 2009 and the grant will be awarded by May 31st, 2009.

Eligibility requirements: 1) University degree from faculties related to audiological and/or otological fields (Medicine as well as Audiology), 2) age under 35 years.

Five Scholarships of 6.000 Euro each will be awarded.

Hearing Handicap among the Homeless in America

Each day hundreds of thousands of people experience homelessness in American cities. The most visible form of homelessness consists of the chronic homeless who have adjusted to life on the streets and in shelters. However, there are also economically and situationally homeless who are likely to be high school graduates. These individuals are frequently employed, seeking employment or have been employed. Finding and maintaining employment is a persistent problem for these homeless persons, presumably including those with hearing loss. Government agencies and non profit organizations typically address homeless persons health needs only in response to crisis situations, resulting in short-term treatments with minimal follow up. Hearing health care needs are usually not addressed at all.

Little is known about hearing loss among homeless persons. This is despite the fact that homeless persons are exposed to risk factors for hearing loss including military and occupational noise exposure, the human immunodeficiency virus (HIV), tuberculosis (TB), and hepatitis. In one study, 18.8% of homeless subjects reported hearing problems. However, the extent to which hearing loss might affect the employability of homeless adults is unknown.

A little about Hong Kong

Hong Kong was a dependent territory of the United Kingdom from 1842 until the transfer of its sovereignty to the People's Republic of China in 1997. The Sino-British Joint Declaration and the Basic Law of Hong Kong stipulate that Hong Kong operate with a high degree of autonomy until at least 2047, fifty years after the transfer. Under the policy of "one country, two systems", the Central People's Government is responsible for the territory's defense and foreign affairs, while the Government of Hong Kong is responsible for its own legal system, police force, monetary system, customs policy, immigration policy, and delegates to international organizations and events. ❖

Hearing Handicap among the Homeless

In 2007, the authors described the outcome of a project in which economic and situational homeless persons were provided hearing screening services as part of a comprehensive health care program at an urban homeless shelter¹. Services provided to these individuals included otoscopy, immittance and pure tone testing. Of the 132 homeless adults described in this study, 83 (63%) were men and 49 (37%) women. Subject ages ranged from 18 to 69 years. All subjects were either employed or actively seeking employment at the time of their hearing screening.

Hearing test results indicated that 47 subjects (35.6% of the total subjects studied) exhibited hearing loss if their bilateral high frequency pure tone averages were calculated at 1 Khz, 2 Khz and 4 Khz. Of these 47 subjects with hearing loss, 17 subjects exhibited mild high-frequency hearing loss (25–29 dB HL bilateral PTA), 16 subjects exhibited mild to moderate high-frequency hearing loss (30-44 dBHL bilateral PTA) and 14 subjects exhibited moderate hearing loss or worse (> 44 dBHL bilateral PTA). The presence of bilateral high frequency hearing loss in this group should not be underestimated; bilateral high-frequency hearing loss and hearing handicap appear linked². Consequently, the authors estimate that 10.6% of 47 subjects experienced sufficient hearing handicap to require hearing aids use.

In summary, the authors found that over 35% of homeless subjects experienced some degree of hearing handicap, and over 10 % of the subjects exhibited hearing handicap sufficient to require the use of hearing aids. These findings suggest hearing loss could hamper the efforts of homeless individuals with finding and maintaining employment. The authors therefore urge vocational counselor training to include information on the psychosocial ramifications of hearing handicap. Vocational counselors should also understand that special accommodations may be needed, such as hearing aids or other prosthetic devices. Finally, vocational counselors should understand how to employ compensatory strategies for effective communication with their hearing handicapped clients.
